## Challenging badge holders

All Minneapolis-St. Paul International Airport (MSP) badge holders are required to challenge any individual who is not properly displaying a valid airport identification badge in secure areas.

The badge must be worn above the waist and on the outermost garment. If a badge is not produced, the challenger must notify the MSP Airport Police Department immediately (call 911) and provide a description and location of the individual(s).



When possible, the challenger should stay with the unauthorized individual(s) or keep them in sight. The \$awbucks Program, which is a security awareness initiative at MSP, will award individuals with cash for reporting security violations or suspicious activity.

## Concourse passes and tools of the trade



Please review the following processes regarding contractors' use of concourse passes and tools of the trade:

- Concourse passes should be requested for un-badged
- A badged employee needs to meet the contractor on the public side no escort authority is required.

contractors (the contractors should not be simply escorted).

- The badged employee should inspect the tools (prohibited items) and make a list.
- The badged employee will bring the tools through a TSA checkpoint, where the tools are screened by the TSA. The contractor will present his or her concourse pass and

identification, and all individuals will be screened by TSA employees.

- The badged employee must maintain control of the tools by monitoring the work the entire time.
- After completion of a job, the badged employee must ensure that all tools (use the list created) that were brought into the secure area leave with the contractor.

• Do not use concourse passes in lieu of the badging process. The maximum number of times an individual can enter the secure side using a concourse pass or an escort is seven.

## Unmanned exit technology -- see how it works

Unmanned exit technology is currently operational at Terminal 2 and at the skyway to the InterContinental Hotel. Additional units will be installed at Terminal 1 beginning this fall.

Please note that once you enter the first set of doors, you must exit all the way through the unit and you are not able to re-enter.



Attempting to re-enter the doors is considered an attempted security breach and violators will be prosecuted. Please pass along this information to your staff.

## Ways to avoid common authorized signer errors

Avoid these common mistakes:

- Signing applications before they are complete
- Signing applications without reviewing two forms of ID
- Signing applications that have disqualifying crimes checked off; these applications cannot be processed
- Not reviewing applications and IDs before signing the application (addresses don't match, for example)
- Signing blank applications
- Sending employees to the Badging Office without an appointment

### Walk-In badging queue overview

- Applicants who are late to their appointments will be turned away. Applicants should be told to be at the office 15-20 minutes prior to their appointment.
- The Walk-in Queue is open 15 minutes before the Badging Office opens. Sign up as early as possible.
- Walk-in Queue appointment times can be extended using the text messages; be sure to read and respond to those.

#### Disqualifying crimes

- Encourage applicants to be honest during the interview process. Remind them that the information is public and that we will find out if they have a record of a disqualifying crime. If applicants have questions, contact mspbackgrounds@mspmac.org.
- Use page 3 of the badge application as your guide.
- Use public search sites to determine if an applicant may have a record of a disqualifying crime.
- Refer employees who have court documents to us, so that we can verify status. Reach us at mspbackgrounds@mspmac.org
